## Dear James

I refer to your email of 8 May 2024 requesting, under the Official Information Act 1982 (OIA),

The names of any non Defence Force personnel that have flown on any NZDF aircraft leaving from Wellington - arriving Chatham Islands between 4th May 2024 and 8th May 2024.

All emails, texts and records of phone calls relating to or mentioning Julie Ann Genter and travel on a NZDF aircraft if this has occurred. This should include all booking/confirmation details, time of confirmation etc, if any.

Apologies for the delay. The New Zealand Defence Force (NZDF) operated flight NZH248 (a C-130H Hercules) from Wellington to the Chatham Islands on 7 May 2024. On board were 37 passengers, including 20 public officials. The names of the officials are below, along with their agency. The names of the remaining passengers are withheld in accordance with section 9(2)(a) of the OIA, to protect their privacy.
