I refer to your email of 18 June 2024 requesting information under the Official Information Act 1982 (OIA), regarding the *NZDF-Beca alliance*. Answers to the parts of your request are provided below:

#### - What major projects have been completed as part of the NZDF-Beca alliance?

There is no *NZDF-Beca alliance.* The New Zealand Defence Force (NZDF) Defence Estate and Infrastructure (DEI) Alliance comprises four partners: the NZDF, Beca, GHD and EY. From 24 November 2020 to 30 June 2022, GHD was a subcontractor to Beca. Since 1 July 2022, GHD has been a full partner of the DEI Alliance.

The DEI Alliance provides a range of professional services to deliver the Cabinet-approved Defence Estate Regeneration Plan (DERP) Business Case (updated in 2019). The DERP outlines a comprehensive strategy for upgrading and maintaining NZDF facilities and infrastructure. The plan focuses on modernising and enhancing the defence estate to support the NZDF's operational capabilities and to ensure the Defence estate meets future needs.

The DERP required the NZDF to transform DEI in order to build capability and capacity for the delivery of the regeneration plan. The Alliance partners were brought on board to provide the specialist infrastructure disciplines required to deliver complex, bespoke military infrastructure. These include: architects; quantity surveyors; the preparation of complex business cases; technical design authorities, specialist environmental and contamination services; and programme management.

The DERP (2019) contains initiated projects with a total capital value of \$3.8 billion (including \$1 billion of housing). Not all of these projects are fully funded. As outlined in the November 2023 Briefing to the Incoming Minister of Defence: *it is estimated that effectively maintaining and regenerating the estate requires \$400 million annually over many years*.

The DEI Alliance has 78 projects at various stages of completion: in design; design complete; ready for procurement; in procurement; in construction: and construction complete. Seven of these projects are currently at the construction complete stage. Please refer to the enclosed list.

How much has the Defence Force paid Beca since the alliance started?How much has the Defence Force paid EY since the alliance started?

For the DEI Alliance, the NZDF paid \$161,003,642.76 to Beca from 24 November 2020 to 31 May 2024. This included payment to GHD from 24 November 2020 to 30 June 2022, when GHD was a subcontractor to Beca. The NZDF does not hold financial information on the split of fees between Beca and GHD from 24 November 2020 to 30 June 2022.

The NZDF paid \$39,432,087.47 to EY New Zealand Limited from 24 November 2020 to 31 May 2024. The NZDF paid \$22,004,808.90 to GHD Limited from 1 July 2022 to 31 May 2024.

- How much has been spent on design costs as part of the alliance?

Design costs are part of the overall capital cost of a project and are not separately recorded. This part of your request is therefore declined in accordance with section 18(e) of the OIA.

- Any communication or reports raising concerns around the alliance, over the last six months.

This part of your request is declined in accordance with section 18(e) of the OIA as no information was identified from that time period that raised concerns about the DEI Alliance.
