I refer to your email of 8 July 2024 requesting, under the Official Information Act 1982 (OIA), information on New Zealand Defence Force (NZDF) Summary Trials and breaches under section 74/1 of the Armed Forces Discipline Act 1971 (AFDA). A response to your request is set out below.

Can I please request the data for the 2022/2023 year showing the total number of summary trials conducted by the NZDF as well as the outcomes of each?

I'd like these grouped by the offence in the same way the 2021/2022 report lays these out (by their AFDA section) displaying the totals for each offence tried.

I'd also like a table showing the breakdown by gender, and by which service the offender serves with - as per the 21/22 document.

The above data request obviously mirrors the data outlined in the military justice annual report, with some omissions. Given that the report was a trial report and hasn't been repeated I'm attempting to fill in the gaps.

Responding to this OIA in a format similar to that annual report would be really helpful.

Summary Trial data for the 2022/23 financial year is at Enclosure 1.

I'm also keen to have more information on breaches under section 74/1 under the act - offences against the civil law of New Zealand.

I would like to request a brief summary of each incident in the 2021/2022 and 2022/2023 years involving either an assault or indecent assault charge that was dealt with at a summary trial level.

These summaries need only be a paragraph or so long and outline the circumstances in which the incident occurred, the rank of those involved, the case number and the outcome.

I appreciate that these will be redacted to protect the identities of those involved.

Breaches under section 74/1 of the AFDA for the 2021/2022 and 2022/23 financial year are at Enclosure 2 and Enclosure 3 respectively. Where indicated, personal information is withheld in accordance with section 9(2)(a) of the OIA to protect privacy. Unfortunately,

some charge details are missing from the tables. Summary Trial data is not centrally recorded so these details are being sought from the relevant Commanding Officer, which is taking some time. The information will be provided to you by 29 October 2024, with personal information withheld in accordance with section 9(2)(a) of the OIA for the reason explained above.

You have the right, under section 28(3) of the OIA, to ask an Ombudsman to review this response to your request. Information about how to make a complaint is available at www.ombudsman.parliament.nz or freephone 0800 802 602.

Please note that responses to official information requests are proactively released where possible. This response to your request will be published shortly on the NZDF website, with your personal information removed.

I also refer to your emails of 1 October 2024, requesting the following information:

I just had a quick question in regard to the charge summaries for the various assault cases - the cover page notes that further information will follow - will that information have more details about the nature of the assaults that have taken place? Specifically, I'm hoping they will differentiate between something like a punch or an incident of groping / unwanted sexual advances.

And:

Why is it that some of the cases have extra detail? i.e:

In that he, at Auckland, on or about 24 October 2020, assaulted by kissing her on the cheeks and forehead whilst sitting on a footpath.

In that he, on board HMNZS Te Kaha, on or about 15 November 2021, threatened by gesture by raising his fist and holding it in the direction of face.

This is specifically the level of detail I'm after.

I'd also argue that requesting this minimal level of detail for only 43 cases of assault and indecent assault from Enclosures 2 & 3 does not amount to substantial effort.

NZDF have the location, date and the names of those involved in its central database.

Requesting information for each of those, while time consuming, doesn't fall into the realm of excessive. Perhaps if the cases were in the hundreds or more then sure.

I would like basic summaries which detail the nature of the offences I've requested in a manner consistent with the two examples I've referenced above.

The records that the NZDF holds in respect of Summary Trials are not akin to records held in the civilian justice system. Summary Trials do not produce the same level of documentation and reporting as District Court proceedings. Notably, no court reports or written judgements are created for Summary Trials. Written judgements only occur if an allegation is appealed to the Summary Appeal Court of New Zealand, or is brought before the Court Martial of New Zealand.

The information you were provided was extracted from relevant MD601 forms, which are the only centralised record for Summary Trials. As prescribed by the Chief of Defence Force, the MD601s record the disclosure, the plea, and the finding. The Disciplinary Officer is not required to summarise the circumstances of each case in detail when completing an MD601. Some may choose to, which is why the level of detail is not consistent. A search through individual personnel files would be required to find further information, if it exists. This would require a substantial collation and research effort.

The Presenting Officer's outline of the case and the statement of fact may contain some, if not all, of the details of the case. However, the NZDF holds this information solely on behalf of the Disciplinary Officer in his or her capacity as a judicial officer in a tribunal. A Summary Trial is a tribunal for the purposes of section 2(6)(b) of the OIA, and as such any information related to it is not official information. For the NZDF to provide you with *basic summaries*, it would require the NZDF to create information that is not held.

You have the right, under section 28(3) of the OIA, to ask an Ombudsman to review this response to your request. Information about how to make a complaint is available at www.ombudsman.parliament.nz or freephone 0800 802 602.
