I refer to your email of 22 July 2024 requesting, under the Official Information Act 1982 (OIA), information concerning New Zealand Defence Force (NZDF) Chaplaincy. Specifically, you have requested the following information:

How many chaplains does the Defence Force employ?

There are currently 24 Regular Force Chaplains and five Reserve Force Chaplains. NZDF Chaplains are available 24/7 providing support to uniformed personnel, civilian staff, and their respective families. Support to former members of the NZDF is also available in a number of areas such as funerals, reunions, welfare matters, and can be a key link to ensure ongoing support is received. Chaplains are from a range of backgrounds and cultures and work to find the right support for NZDF members and their families.

What is the religion division of these chaplains?

At present, all of the NZDF Chaplains are drawn from the Christian tradition representing a range of different denominations. There are efforts underway to broaden this representation in consultation with other faith bodies.

How many are currently on base as at 22/7/2024 and how many are deployed?

As at 22 July 2024, there were 18 Regular Force Chaplains posted to a Camp or Base and two deployed. Four were either on leave or undertaking required courses.

How much overall is spent on chaplains overall remuneration, and how much is budgeted for chaplaincy services as a whole in the Defence Force?

For the 2023/24 financial year, the total remuneration costs for both Regular Force and Reserve Force Chaplains was \$2,876,257. Remuneration costs for the 2024/25 financial year are expected to be similar. The operating budget for the 2024/25 financial year is \$260,590.

I refer to your emails of 26 August 2024 seeking further information about the operational spend for Chaplains, and specifically requesting the breakdown of the \$260,590 operating budget for the 2024/25 financial year. Your request has been considered under the Official Information Act 1982 (OIA).

A summary of the 2024/25 financial year operating budget is provided in the table below.

Training and Development	\$71,000

Meetings	\$11,000
Travel	\$34,000
Communications	\$27,000
Uniforms and Clothing	\$25,000
Vehicle Running Costs	\$44,000
Miscellaneous	\$7,000
TOTAL OPERATING EXPENSES	\$261,000

With respect to the vehicle running costs, these are for three shared lease vehicles available to the 24 Regular Force uniformed chaplains.
