I refer to your email of 5 August 2024 requesting, under the Official Information Act 1982 (OIA), the number of homes and barracks that are exempt from the Healthy Homes Standards and the reasons why for each house and barrack. You have requested this information to be broken down by each military camp and the number of homes and barracks each military camp services.

New Zealand Defence Force (NZDF) barrack accommodation is not legally subject to the Healthy Homes standards as laid out in section 5(1)(f) of the Residential Tenancies Act 1986 which states:

This Act shall not apply in the following cases: ... where the premises constitute any barracks conducted by the Armed Forces for the accommodation of persons subject to the Armed Forces Discipline Act 1971.

This is because the NZDF does not enter into a tenancy agreement for the provision of barrack rooms. All of the barrack buildings are still subject to the Building Code and all other relevant legislation for health and safety.

Houses used by the NZDF for residential tenancy have been upgraded to meet the requirements of the Residential Tenancies (Healthy Homes) Regulations 2019. The regulations sets out standards for various aspects of a house (e.g. ceiling insulation, underfloor insulation, ventilation, heating, draughts, and moisture barriers) to comply with. However, the standards listed do not have to be met if it is not reasonably practical. For example, in some houses it is not possible to get into the space under the floor to fit insulation or moisture barriers without removing the floor itself. The regulations use the term exemption to describe these situations. Houses with exemptions still meet the requirements of the regulation.

There are 263 houses that are used by the NZDF for residential tenancy that are exempt from one or more of the component standards under Part 2, subparts 2-6, of the Residential Tenancies (Healthy Homes) Regulations 2019. This is because it is not reasonably practicable to complete the work. Enclosure 1 provides a breakdown of these properties by location and by exemption.
